LEADERSHIP BOERNE ATTENDANCE POLICY

Leadership Boerne is a **TWO-YEAR COMMITMENT** designed to provide skills and information for participants to become more effective community members. To accomplish this, participants are expected to **commit to attend and fully participate in all scheduled classes and events.** It is a disservice to the credibility of the entire program and unfair to your classmates, if participants arrive late or fail to attend classes and events. **Graduates must also commit to serve on a Chamber Council, Chamber Committee in some capacity or to serve a local a non-profit organization within the first year of Graduation to allow an ongoing contribution to the community.** With this in mind, **all applicants should agree to the commitment policy as stated below** when applying for this program.

Commitment:

1. I certify that I am available to attend, in full, the Leadership Orientation as scheduled. I understand that **if I cannot attend the Orientation in full, I will not be able to continue in the program.**
2. It is my intention to arrive at all sessions at the scheduled start time and not to leave until the scheduled completion time. I understand that five (5) occasions of late arrival or early departure where the absence exceeds thirty (30) minutes will result in automatic dismissal from the program. I understand that leaving a program session in progress for more than thirty (30) minutes shall be counted as one occasion of early departure, whether or not I return.
3. I understand and agree that if I should be absent from program sessions totaling, in the aggregate, more than two full program sessions, I will not be able to graduate and will forfeit, in total, my tuition. I understand this means missing an entire session and/or parts of several sessions which, when combined, total more than two full sessions. If I miss a session or any part of a session, I understand that I may be required to makeup that session in the next Leadership Boerne program, and that my Diploma may be withheld until I have made up the absence.
4. I understand that I must attend **two of the following meetings** during my year as a Leadership Boerne participant: Boerne City Council Meeting (Second & Fourth Tuesday at 7:00 pm), Kendall County Commissioners Court Meeting (Second & Fourth Monday at 9:00 am) or Boerne Independent School District Trustees Meeting (Third Monday @ 6:30 pm). More details to follow.
5. In all attendance matters or matters of policy, I agree that the decision of the Leadership Boerne Steering Committee shall be final and **I agree to abide by their decision.**
6. I understand and agree that I will be significantly involved in participating in class sessions and understand that this is a graduation requirement.
7. I understand that **LEADERSHIP BOERNE IS A TWO-YEAR COMMITMENT**; one year as a student and one year as a facilitator for the subsequent Leadership class.
